Pursuant to Clause 4, Article 14, Chapter III of Circular No. 96/2020/TT-BTC issued on November 16, 2020 and effective from January 1, 2021 by the Ministry of Finance, providing guidelines on information disclosure on the securities market, Vietravel would like to provide the following explanation regarding the change of 10% or more in Combined profit after tax in Q1/2025 compared to Q1/2024:

## Explanation:

The continuation of policies implemented since 2024 has brought positive results: revenue in Q1/2025 increased by 8.07% compared to the same period in 2024.

However, the Company still faced several challenges that caused profit in Q1/2025 to decrease by 26,84% compared to Q1/2024. Specifically, the following factors had significant impacts on the Company's profit: cost of goods sold increased by 7.64%; selling expenses increased by 29.68%; and interest expenses increased by 34.74%. These are the main reasons for the decline in profit in Q1/2025 compared to Q1/2024.
