3. Supervising Board of Directors, Board of Management and shareholders by Board of Supervisors or Audit Committee:

- 3.1. Review of the Board of Directors' performance in 2024
 - Annual General Meeting of Shareholders 2024:
 - The Board of Directors directs the completion of the organization of the Annual General Meeting of Shareholders on May 11, 2024 in Hue. The organization is carried out in accordance with the procedures prescribed in the Company Charter and current Law. The Board of Directors reports to the General Meeting of Shareholders on the

work completed in 2023 and presents the plan for 2024.

- The minutes and resolutions of the General Meeting of Shareholders were approved and disclosed in accordance with the provisions of the law. Out of the 17 items in the 2024 General Meeting of Shareholders' resolutions, the Board of Directors has completed 15 items. One item related to the plan to issue shares for increasing charter capital has been implemented but was not completed in 2024. Additionally, one item concerning the private offering of convertible bonds in the domestic market has not yet been implemented.
- Complete the content of adjusting the Internal Regulations on Corporate Governance according to the Resolution of the 2024 Shareholders' Meeting approved.
- Complete the content of adjusting the Board of Directors' Operating Regulations according to the Resolution of the 2024 Shareholders' Meeting approved.

HAGNA

- Complete the content of the Company Charter adjustment according to the Resolution of the 2024 Shareholders' Meeting approved.

Personnel situation:

- The Board of Directors issues resolutions and decisions on personnel in accordance with the authority prescribed in the Company's charter. In 2024, the Board of Directors implemented a structure for evaluating and appointing leadership personnel, including 92 related decisions on middle-level leadership personnel.
- Disclose information according to the regulations of public companies for insiders and related persons of the Company as prescribed in Article 4, Clause 45, Clause 46 of the Securities Law 2019.

Financial situation, audit:

- Complete the signing of the 2024 financial statement audit contract with AFC Auditing Company Limited according to the approved Resolution of the General Meeting of Shareholders. The audit contract was signed on June 26, 2024.
- Complete the preparation of quarterly financial reports, semi-annual financial reports, annual financial reports and conduct audits in accordance with regulations.
- Closely supervise the Executive Board in directing and managing finance, cash flow, receivables, payables, and ensuring timely and complete accounting.

& Business situation:

- Decision to establish Tuy Hoa, Bac Ninh, Nam Dinh, Phan Rang Tourism Registration Offices, Caravan Center and Joint Venture Company in India to expand the business network in domestic and international regional branches.
- The Board of Directors has directed the Executive Board to implement the development of a financial plan based on the business plan approved by the General Meeting of Shareholders..
- The Board of Directors organizes monthly meetings to attend the report presentation from the Executive Board on the business situation, the implementation of the company's overall financial plan, evaluate, and make strategic decisions based on actual conditions, providing direction for the activities of the following month.
- The implementation of the 2024 business plan, with the results as follows:
 - Revenue reached 6,716.8 billion, achieving 97% of the plan (Annual plan: 6,921 billion)

• Gross profit reached 564.6 billion, achieving 85% of the plan (Annual plan: 666.1 billion).

Corporate Governance:

- The resolutions and decisions issued by the Board of Directors in 2024 to support corporate governance were implemented in accordance with the authority prescribed in the Company's Charter and the provisions of the Enterprise Law.
- The Board of Directors has issued 46 resolutions and directives related to business operations, the expansion of domestic and international branch networks, financial management, and other matters, promptly addressing necessary adjustments during the company's business operations.
- The regulations that have been amended or newly issued and are currently in effect include: the Labor Discipline Handling Regulation, the Regulation on Delegation of Authority between the Board of Directors and the General Director, the Regulation on the Board of Directors' Operations, the Decision on Work Allocation among Board Members, and the Regulation on the Relationship between the Parent Company and its Subsidiary Limited Liability Companies.

Disclosure of information as per regulations:

- In 2024, the company has disclosed 52 pieces of information in accordance with the Securities Law on the CIMS system of the Hanoi Stock Exchange (HNX) and on the company's website. These disclosures include the following content:
 - + Periodic information disclosure applies to the quarterly; semi-annual, and annual financial reports for 2023; audited by an independent auditing firm, as well as the corporate governance report and the annual report.
 - + Extraordinary information disclosure within 24 hours and other exceptional disclosures include documents related to the 2024 Annual General Meeting of Shareholders, resolutions/ decisions on the establishment/ dissolution/ investment in subsidiaries, other disclosed information about insiders and their related parties, stock transactions of insiders, notifications related to the company's activities, etc.

3.2 Review of the Executive Board's activities in 2024

- The documents issued by the Board of Directors in 2024 are within the assigned responsibilities and authority according to the decentralization regulations issued by the Board of Directors.
- Implement the Board of Directors' instructions fully and promptly.
- Timely management of business performance and financial management on a weekly and monthly basis, closely following the plan assigned by the Board of Directors through regular briefing meetings.
- The Executive Board has directed the Finance and Accounting Department to closely monitor and oversee the implementation of accounting tasks across the company, verify and reconcile data, and accelerate the preparation of periodic financial reports in accordance with regulations.
- In addition, the Internal Audit Department has coordinated with the Finance and Accounting Department of the company and the accounting departments of subsidiary branches to check compliance with financial management and accounting regulations, as well as the Ministry of Finance's requirements. They promptly identified deficiencies and reported them to the Executive Board for corrective instructions. In

2024, the Internal Audit Department conducted on-site inspections at several branches that had not complied with general management procedures and had errors in financial management and accounting. After each inspection, the results and recommendations were sent to the Board of Directors and the Executive Board.

- The implementation of the regulations, rules, and procedures issued throughout the company is closely monitored. The overall performance of the units is evaluated, and reports are submitted thoroughly. However, some units still have discrepancies.

4. The coordination of activities between the Audit Committee and the Board of Directors, the Executive Board, and other management personnel:

- The Internal Audit Committee is part of the Audit Committee under the Board of Directors and operates according to its own plan, under the direction of an independent Board of Directors member responsible for overseeing. The Audit Committee reports any issues that may pose risks to business operations or management activities promptly to the Board of Directors and informs the Executive Board of any aspects that need attention and adjustment in business activities.
- The leaders of the units have closely coordinated in the inspection and monitoring activities.
- Quarterly, the Audit Committee informs the status of inspection and monitoring, provides feedback, and submits recommendations to the Audit Committee, Board of Directors, and Executive Board of the company to ensure timely direction in management and cost control activities.
