3. Supervisory activities of the Audit Committee towards the BOD, Executive Management Board, and shareholders

3.1. Review of the BOD's activities in the first 6 months of 2025

* Implementation status of the 2025 Annual General Meeting of Shareholders:

The BOD successfully directed the organization of the Annual GMS on 17/05/2025 in Quy Nhon. The organization complied with the provisions of the company's Charter and current laws.

The BOD reported the 2024 performance results and presented the 2025 plan to the GMS.

The minutes and resolution of the 2025 GMS were approved and disclosed in accordance with regulations. Among the contents of the GMS resolution, the BOD has completed the following amended and supplemented items:

- Completed the amendment of the charter regarding the change of name and addition of business lines. The 17th amended charter dated 16/06/2025.
- Completed the application for a business license under the new name: Vietravel Tourism Joint Stock Company, 38th time, on 11/06/2025.

- Completed the adjustment of the business plan for 2 targets, revenue and gross profit, according to the figures approved by the 2025 GMS: Revenue of 8,418 billion VND, Gross Profit of 749 billion VND.
- Completed the amendment of the operational regulations of the Board of Directors, issued and applied on 16/06/2025.
- Completed the amendment of the internal regulations on Corporate Governance, issued and applied on 16/06/2025.
- Implemented the signing of the independent audit contract.

The uncompleted items are in the process of implementation, including:

- Currently implementing the offering of shares to increase charter capital under the program of offering shares to existing shareholders, ending on 08/08/2025.
- Not yet issued shares to increase charter capital under the Employee Stock Option Program (ESOP) of 2,865,824 shares.
- Not yet issued shares to increase charter capital from equity sources of 8,597,474 shares.
- The record date for cash dividend payment is expected to be on 25/07/2025.

* Corporate governance status:

The BOD has issued 22 resolutions and 04 Regulations as of 30/06/2025 to implement amendments, supplements, and create new regulations in line with new state regulations effective from 01/07/2025, including:

- Assignment of BOD members for 2025
- BOD Operational Regulations
- Internal Regulations on Corporate Governance.
- Regulations on Non-Cash Payments
- Regulations on Sending Employees on Overseas Business Trips and Employees on Leave/Unpaid Leave for Overseas Travel.

* Orientation on restructuring the network system

- Implemented the renaming of the company's subordinate units according to the new business license: Vietravel Tourism Joint Stock Company, 38th time, on 11/06/2025.
- Restructured the nationwide business network towards being lean and efficient.
- Established the Dong Xoai Tourism Registration Office under the Binh Duong Branch, established and implemented the Ecommerce project to develop online sales.
- Implemented the transfer of shares of Cdimex and Worldtrans companies from Vietravel Group Joint Stock Company.

* Organizational structure - personnel:

- Decisions on the appointment and dismissal of mid-level personnel were carried out by the BOD in accordance with the prescribed procedures and authority.
- In the first 06 months of 2025, the BOD decided to extend the appointment term for the position of Acting Chief Accountant of the company until the end of 31/07/2025.
- In addition, the disclosure of information related to insiders and related persons was fully implemented in accordance with Article 4, Clauses 45 and 46 of the Securities Law 2019.

* Financial and audit situation:

- Signed an audit and review contract for the 2025 financial statements with AFC Auditing Company Limited according to the GMS resolution. The contract was signed on 17/07/2025.
- Completed quarterly, semi-annual, annual, and audited financial reports on schedule.
 The reports reflect a true and fair view of the company's financial position, in accordance with accounting standards as regulated.
- The Executive Board was closely supervised in cash flow management, debt, and timely and complete accounting records.

* Business situation:

- Implemented business plans for each region such as: Mekong Delta region, Central region, Northern region.
- The BOD holds regular monthly meetings to monitor the operational situation and make executive decisions appropriate to the actual business situation.
- In the first 06 months of 2025, the Vesak Grand Ceremony was successfully held.

- Results of the 2025 business plan implementation (estimated):

- o Revenue: 3,334 billion VND, achieving 40% of the plan
- o Gross Profit: 275 billion VND, achieving 37% of the plan

* Information disclosure:

- As of 30/06/2025, the company has disclosed 31 information disclosure documents on the CIMS system (HNX) and the company's website on time, including:
 - o Periodic reports: quarterly, semi-annual, annual 2024 financial reports; corporate governance reports, annual reports,
 - o Irregular reports: personnel changes, share transactions, GMS documents, GMS minutes and resolutions, related transactions.

3.2. Review of the Board of General Directors' activities in 2025

- Documents were issued in accordance with the authority and responsibility under the delegation of authority regulations.
- o Directed the full and timely implementation of BOD resolutions.

- O Held regular weekly/monthly briefing meetings to update the business and financial situation, and issued directive documents after the meetings, with implementation results reported at the next meeting. The company's Board of General Directors is quite thorough in management, timely grasping the company's business activities.
- o The Board of General Directors has directly supervised and guided the Finance-Accounting Department in preparing financial statements, verifying data, and managing the accounting work for the entire company.

4. Coordination between the Audit Committee and the BOD, the Executive Board, and other departments

- The Internal Audit Department under the AC submits an annual internal audit plan.
- The Internal Audit Department under the Audit Committee reports periodically and irregularly on risks and shortcomings in the business operation process to the AC and the BOD, provides independent assessments, recommends remedies and preventions, and sends notifications to the Executive Board.
- The Internal Audit Department is provided with all necessary information and documents by the Executive Board for regular periodic inspections at the units.
- The Internal Audit Department under the AC monitors the implementation of recommendations and the correction of existing violations.
 - Reviews and approves the plan, ensuring its independence and completeness.
- The BOD and the Executive Board receive reports, review, make recommendations, and direct corrective actions.
- Audit reports are sent quarterly to the BOD and the Executive Board for cost management and operational direction.
- The BOD, the Executive Board, and the AC always coordinate closely in their activities, aiming for the goal of operating the business with productivity and efficiency.
